

The scheme is informed by four principles and values. These should be kept in mind when updating your portfolio and providing evidence of your professional development. Central to the scheme is the definition of learning technology agreed within ALT.

"Learning technology is the broad range of communication, information and related technologies that can be used to support learning, teaching, and assessment."

A commitment to exploring and understanding the interplay between technology and learning

"Don't Let the Technological Tail Wag the Pedagogical Dog" (Unknown)

I hope that throughout my portfolio you have recognised my constant insistence that technology and the use of technology does not replace the learning. Whether it's developing an online programme of study, short online activities, or working with academics to design assessment briefs for using Mahara, pedagogy should always come first, and it is my job to find the tools that best supports it.

A commitment to keep up to date with new technologies

I understand the value in including a large range of stakeholders when working on projects. I am fortunate to be able to say that I can approach the use of technology with 3 major hats on: a teacher, and learner, and a technologist. However my approaches have been shaped by own experiences, and therefore cannot 100% ensure that my decisions will be accepted by everyone and that's why I am keen to ask for reviewers for my work (colleagues), lecturers and students).

A commitment to communicate and disseminate effective practice

As mentioned previously, I am now having to be inventive with sharing what I am learning and physical attendance of events have been restricted. I will, however, keep on blogging, writing, webcasting, and tweeting about what I am working on, and supporting those in need of guidance beyond the walls of my institution.
